Exercise. It is easy to see that the following is true: For a hypergraph $H = \langle V, E \rangle$, the hypergraph $H' = \langle V, E \cup \{e_V\} \rangle$ is acyclic with e_V a hyperedge that contains every vertex of V. Therefore, every BCQ can be transformed into a tree query by adding suitable atoms. Does this imply that every BCQ can be answered in polynomial time? - Then φ is satisfiable iff there is a homomorphsim from I_{φ} to \mathcal{J} .
